Dear parents/guardians,

This past year has been a trying time for many, especially our youth and teens. The impact of COVID-19 has changed the way our teens have lived their lives; they have not been able to attend classes in person and learn in a way in which they thrive, socialize with their friends every day, or participate in activities that help develop their social skills as they transition into young adulthood. This summer, the Boys and Girls Club of Flagstaff is offering a teens-only summer camp aimed at offsetting some of the impacts this year has had on our teens.

We are offering programs to help teens catch up on some of the learning they have lost this past year, get active, use their creative side, sharpen up their social skills, and participate in healthy competition. Along with these daily programs, we offer free choice options to ensure your teen has the best time at our club. These choices can include Around the World, French/Spanish Club, Skateboarding, Painting, Garden Club, Video Game Club, Yoga, Medics of the Future, Teens in the Kitchen, and more. We ask that you please fill out our free-choice interest survey at the end of this packet so we can provide the most sought-after options.

Our summer camp will be at our main site, 301 S Paseo del Flag, and we could not be more excited to make use of our newly renovated spaces! Registration is on a first come, first serve basis. We have a cap of 80 members to ensure that we stay well within our COVID capacity, and these spots will go fast! There is an initial \$20 membership fee, which is good for a year. There is also a \$70 weekly fee (or \$14 per day). We do have tuition assistance available; tuition assistance forms are available upon request. **TO RESERVE YOUR SPOT: submit this completed registration packet, the \$20 membership fee, and a \$10/week registration fee for each week you would like to register your teen for this summer.** The \$10/week registration fee is applied toward your weekly fee. Registration packets will be at our Cogdill location at 301 S. Paseo Del Flag and online on our website at bgcflag.org. All new and returning members will be required to fill out the registration packet.

With COVID still prevalent, we will be taking the safety precautions. We will have no more than one staff to ten members, we will be cleaning throughout the entirety of the day, and having temperature checks at the beginning of the day before entering the building and before lunch. If a member or staff reads a temperature of 100.4 or higher, they will be sent home for the protection of the other members and staff. Hand washing will be completed multiple times a day and we will also have a full time cleaner to combat dirt, bacteria, and virus spread. Lastly, no one with the exception of the camp members, staff, and volunteers will be allowed to enter the building. All drop off, pick up, signing up for field trips, making payments, and any questions will be conducted outside at the check in/out desk. Consistent with the General Behavior Expectations, the following specified behaviors are prohibited on Club property, including Club vehicles, on field trips or any other off-site activity. Each situation will receive individual attention and disciplinary decisions will be made dependent on the severity of the incident. Disciplinary actions are at the discretion of the Branch Director and Youth Development Supervisor and will be connected to the misconduct in a logical and timely manner.

1. **Bullying/Harassment** – includes any actions or words that make another member feel threatened, uncomfortable or unsafe. These actions or words become harassment when the victim has made it clear that the actions or words are offensive.
2. **Theft/Stealing** – includes the unauthorized taking or possession of the property of another without the consent of the owner.
3. **Fighting/Horseplay** – includes two or more persons engaged in any violent or physically hostile behavior directed toward each other. “Horseplay” includes roughhousing and other playful behavior or play-fighting that, though not intended to harm, presents a reasonable risk of harm or otherwise threatens the safety of students or others. Anyone who encourages or directs another to engage in any violent or physically hostile behavior, i.e. “egging on the fight” may be subject to the same disciplinary action as is the person who engages in the action.

4. **Vehicle Misconduct** – includes failure to abide by the General Behavior Policy while being transported in a vehicle owned or operated by the Boys & Girls Club, or failure to observe any of the following specific rules while riding in a vehicle owned or operated by the Club.

- a. Follow the driver's instruction.
- b. Remain seated with the seatbelt fastened.
- c. Keep all body parts inside the vehicle.
- d. Talk quietly using respectful language.
- e. Be courteous at all times.
- f. Do not throw anything inside the vehicle or from the vehicle.
- g. Do not eat or drink in vehicle.

5. **Defiance** – Includes refusing to obey a reasonable directive issued by any Club employee, including Club volunteers.

6. **Disruptive, Obscene or Disrespectful Behavior** – “disruptive behavior” includes any behavior that distracts from or interrupts the Club programs or activities. “Obscene behavior” includes the use of profanity, the use of vulgar or offensive gestures, or the depiction, display or distribution of materials that are offensive to the commonly accepted standards of decency. “Disrespectful behavior” includes any behavior that is discourteous, rude, insolent, deceptive, or otherwise fails to show appropriate regard for the personal dignity of another. Included in this category is indecent exposure, regardless of the ages of the child.

7. **Vandalism** – Includes damaging, destroying, defacing, significantly altering or mutilating objects, property, or materials belonging to Club members, Club employees, or materials that are property of the Club. Destruction of Club bathrooms or facilities, including intentional flooding of toilets is considered vandalism.

8. **Computer Misuse** – Includes any violation of the Acceptable Use Policy, as set forth in the Membership Pack etc.

ACKNOWLEDGMENT OF RISKS AND WAIVER OF LIABILITY RELATING TO CORONAVIRUS/COVID-19
